National Criminal Database Coverage

Overview

The Alliance 2020 National Criminal database search is one of the most comprehensive database available.

Our National Criminal Database contains over 550 million records from thousands of jurisdictions, including department of corrects (DOC), administrator of the courts (AOC) and sex offender registries from all 50 states.

Due to individual county, state and federal laws, database coverage and access to records may vary by state. Not all Jurisdictions are represented within the database. Many of the jurisdictions are updated on a monthly bases. When using the National Criminal Database, Alliance 2020 recommends ordering county criminal records searches for any jurisdictions the subject has lived, worked, went to school for the past seven years regardless of the jurisdiction included in the database.

The table provides a summary of the available database coverage.

Definitions

Administrative Office of the Courts current and historical felony and misdemeanor information on individuals who are or have been under the jurisdiction of the state's court system.*

Department of Corrections - felony information on individuals that are or have been under the jurisdiction of the state's Department of Corrections.*

County Court Records - felony and misdemeanor criminal case information from county Criminal and Superior courts.*

Proprietary Offender Data proprietary criminal data compiled from previously ordered county, statewide and federal criminal requests, from all 50 states.

Sex Offender Registries - Our National Criminal database includes sex offender registries of all 50 states.
