A letter from the creditor must accompany all Rapid Rescore requests for each account. These letters must:

- Be issued (dated) within 30 days of the above request date
- Be printed on creditor's company letterhead with a contact name and phone number
- Include the consumer's name and address
- Include the account number matching the account on the credit report
- Include a specific statement as to what needs to be corrected on the credit report

Rapid Rescoring involving tax liens or judgments must have documentation issued directly from the court

Rapid Rescoring involving bankruptcies must include discharge page and schedule listing creditors

Important Note:

The file upon which the Rapid Rescore is based must have been pulled within in the last 30 days of the original report.
